JORDAN'S THOUGHT FOR THE MONTH: *DREAMING & REACHING HIGHER*

One of the (perhaps) positive impacts of the Trump Administration's tariffs on Canadian goods is that it has exposed Canadian export companies' dependency on the US market. We would rather sell our raw materials to the US than refine or manufacture them into higher value goods. Some of this can be attributed to the 10x population and greater market size in the US, or perhaps tax reasons, but some of it can be attributed to a business culture of complacency – why search out foreign markets when we have an easier market to access a few hundred miles away, with the same language? Canadians also have a bad habit of settling for second or third place, instead of striving to be the best at what we do.

There's a paradox that while the US is historically more libertarian when it comes to government interventions, their professions and occupations are regulated by licensing boards in the respective state government, and conversely, Canada, which is more statist or government-friendly, allows for self-regulation by professional bodies (albeit with increasing provincial oversight). Yes, we may have legislative constraints, but sometimes we are guilty of complacency or only making minor, incremental improvements.

At last month's CNAR Annual Convention, one of the keynote speakers, Canadian Olympic champion swimmer Mark Tewksbury spoke a lot about being open to challenging assumptions, new ideas, processes, and ways of thinking. I have seen "small" regulators (in terms of the number of staff) who "punch above their weight class" in pioneering projects and programs and sophistication that really takes regulation to the next level. It's more an issue of imagination, perspective and willpower, not resources that holds us back. Sometimes we need outside viewpoints and perspectives to help us see things that we can't from within our regulator-centric mindset.
